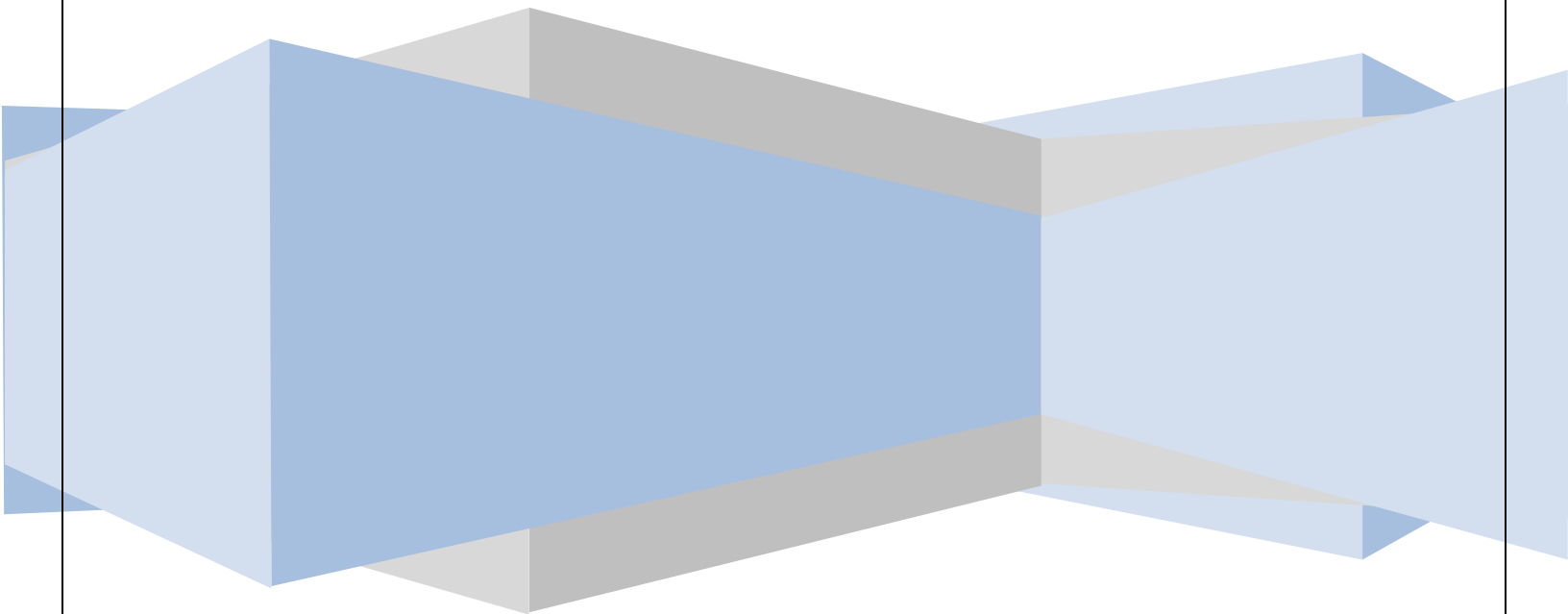

Legal Terms and Conditions

The Soweto Heritage Trust (the “SHT”) is pleased to provide this website, both produced and/or compiled by the 8115 Mandela House to provide the public with information regarding the work of the SHT. The following describes the terms (the “Terms”) that govern your use of the SHT Site, and the services and goods provided through the SHT Site. Your use of the SHT Site constitutes your agreement to all of the Terms. If you do not agree with any of the Terms you may not use the SHT Site. The term “materials” includes all or any information, artwork, text, video, audio, and animation or image files.

1. Use of the SHT Site

(a) Content

The information and materials contained at the SHT Site, including the text, images, arrangement, and general design (collectively, the “Content”) are owned or licensed by the SHT. You are authorized to view or download the Content solely for your personal, educational, non-commercial use provided you retain all proprietary notices contained in the Content. You may not modify copy, distribute, transmit, display, perform, reproduce, publish, license, create derivative works from, transfer, or sell any Content.

Reproduction of the Content except as specifically provided in this paragraph is prohibited without the express written authorization of the SHT, or the copyright / trademark owner. Any publication or commercial use of the Content is strictly prohibited. Copying, redistribution or exploitation of the Content for personal or corporate gain is not permitted.

(b) Prohibited Use

You may not use the SHT Site in any manner which is contrary to applicable local, provincial, national, international and foreign laws or regulations governing your use of the SHT Site. Specifically, the SHT site is both owned and operated from the Republic of South Africa. As a result, the laws of the Republic of South Africa govern these terms and conditions and you consent to the jurisdiction of the Witwatersrand High Court in the event of unlawful use or dispute. It is solely your responsibility to determine whether your use of the SHT Site is lawful. You may not use the SHT Site in any manner which could damage, disable, overburden or impair the SHT Site or interfere with any other party’s use and enjoyment of the SHT Site.

2. Privacy

We only collect personally identifiable information that you provide or that is otherwise provided to us on your behalf. Unless we advise otherwise, your information will only be used for the purpose for which it was provided or to contact you.

3. Disclaimer

The SHT site and the Content are provided on an 'as is, where is' basis. The SHT disclaims all conditions, terms, representations and warranties, express or implied, statutory or otherwise, including but not limited to, implied warranties of merchantability, quality, and fitness for a particular purpose, title and non-infringement, with respect to any of the Content.

The SHT does not warrant that the SHT site and the Content are free from errors or other program limitations or that the SHT site and Content will be accessible and perform in accordance with your expectations. The SHT will not be liable to you or any other person for any damages (direct, indirect, general, special, consequential, or otherwise), expenses, loss of profits, loss of earnings, loss of business opportunities, loss of data or other loss, arising directly or indirectly out of or in connection with the provision, use or failure of the SHT site, and/or the content, whether negligent or otherwise, and which would otherwise give rise to a cause of action in contract, delict, or any other doctrine of law.

5. Indemnity

You agree to indemnify, defend and hold harmless the SHT and its respective agents, directors, officers, employees and licensors, and all other related, associated, or connected persons (collectively, the "Indemnified Parties") from and against any and all liabilities, expenses and costs, including without limitation reasonable legal fees and expenses, incurred by the Indemnified Parties in connection with any claim or demand arising out of, related to, or connected with the use of the SHT Site by you or your breach of this agreement.
